Re: Disadvantaged Business Enterprise (DBE) Program - Interim Final Rule (IFR)

Dear Mr. Cater,

The Colorado Department of Transportation (CDOT) is in receipt of the United States Department of Transportation (USDOT) letter regarding the Disadvantaged Business Enterprise (DBE) Program - Interim Final Rule (IFR) which was posted to the USDOT DBE website on September 30, 2025.

On October 3, 2025, the USDOT published an IFR in the Federal Register modifying the eligibility requirements for participation in the DBE program. Furthermore, the IFR mandates that all currently certified DBEs be reevaluated, and ultimately recertified, for continued program eligibility under these new requirements. 49 C.F.R. § 26.111.

Until additional guidance regarding the IFR is provided, CDOT will take the following steps to conform to the direction of the IFR.

**Federal Aid Contracts**

- For CDOT contracts that have not yet been advertised, CDOT will not set any DBE goals on projects until guidance is received from USDOT regarding the Unified Certification Program (UCP) and the reevaluation process of existing certified DBEs.
- For CDOT contracts that are currently advertised for proposals or construction bid letting, CDOT will issue an addendum or revision to remove the DBE goals.
- For any CDOT advertisement where the proposal due date has passed or construction bids have been formally opened, CDOT will continue with execution of the awarded contract to avoid construction delays and will seek guidance from the Federal Highway Administration (FHWA) regarding enforcement.
- For all executed CDOT contracts, CDOT will continue to enforce the executed contract requirements pending further guidance from the FHWA.
- CDOT will communicate with local agencies to adhere to the above steps for federal aid pass-through local agency contracts.

**Management of the CDOT DBE Program**

- CDOT will work with its Colorado UCP partners to complete the reevaluation process as quickly as practicable in accordance with the IFR.
- CDOT will review new applications under the new certification standards as outlined in the IFR.
- CDOT will not respond to any appeals of DBE applications until further guidance is received from the USDOT.
- CDOT will continue to provide supportive services to the small business community.

We look forward to further guidance and direction on the Unified Certification Program (UCP) and DBE reevaluation process. Please let us know immediately if CDOT's current understanding of the IFR and CDOT's planned implementation as set forth in this letter is inconsistent with FHWA's understanding.

## The Frontline Legend Award

**Honoring compassion, integrity, and leadership where it matters most — recognizing those who build people, not just projects.**

The *Frontline Legend Award* honors the men and women whose leadership is lived in the mud, the dust, and the noise of the jobsite — not behind a desk. It is reserved for those who lead by doing: foremen, field supervisors, operators, and craftworkers whose hands bear the marks of their trade and whose example lifts everyone around them. These individuals are the backbone of our crews — patient teachers, problem solvers, steady voices under pressure, and protectors of both people and quality.

Frontline Legends lead with integrity, humility, and heart. They don't need titles or offices to earn respect; they earn it by showing up early, staying late, keeping their word, and taking care of their teams. They know that true leadership is measured not in authority but in the trust, confidence, and pride they inspire in others.

This award celebrates those rare individuals who build more than projects — they build people, culture, and lasting respect. They are the standard-bearers of what it truly means to lead from the front.

For years, the construction industry has been heavy on self-congratulation at the executive level — banquets, award dinners, and cocktail receptions that feel more like PR than purpose. Meanwhile, the people doing the actual work rarely see their names, faces, or stories anywhere.

## **City of Castle Pines 2026 Capital Projects**

*All of our projects are advertised through BidNet*

- Reconstruct WB Castle Pines Parkway, from Monarch to Forest Park, including all new waterline, in asphalt.
  - The project is expected to be advertised in February with a June 2026 start date.

## **Pavement Maintenance**

## **City of Lakewood 2026 Anticipated Projects**

City of Lakewood projects are advertised for bid on Bidnet. Typical bid duration for construction projects is 3-4 weeks. Contractors are encouraged to join the pre-bid meeting which generally occurs one week after the project is advertised. Questions can be asked during this meeting or submitted to the City purchasing agent up to the question deadline outlined in the bid calendar. All projects anticipated for 2026 will be Design-Bid-Build.

### **West Calahan Avenue Drainage Improvements**

Groundwater along W. Calahan Avenue has been flowing over sidewalks and into the curb and gutter between S. Upham Street and S. Pierce Street. Storm sewer will be installed to redirect these flows off the street to prevent future maintenance and icing conditions.

Advertise for Bid: Q2

Estimated Cost: \$300,000

### **Sheridan Boulevard Sidewalk Improvements**

Construction of a new sidewalk on the west side of Sheridan Boulevard from Jewell to Florida.

Advertise for Bid: Q4

Estimated Cost: \$1,750,000

### **South Wadsworth Boulevard Sidewalk Improvements**

Project will add separated bike/pedestrian paths on Sout Wadsworth Boulevard from West Yale Avenue to West Eastman Place, and from West Jefferson Avenue to West Mansfield Avenue. The project will also include lengthening the existing right-turn lane at West Duquesne Avenue to accommodate a new driveway for the planned parking lot for the Bear Creek Green Belt. The curb ramp at the SE corner of South Wadsworth Boulevard and West Jefferson Avenue will also be reconstructed to meet current ADA requirements. Retaining walls, storm sewers, and other miscellaneous construction items will be included in the project.

Estimated Cost: \$2,000,000

### **South Garrison Street Separated Bike Lane**

Widening on the west side of South Garrison Street to extend the separated bike lane from West Alameda Avenue to West Cedar Avenue. Project will also include median modifications on South Garrison Street.

Advertise for Bid: Q2

Estimated Cost: \$600,000

### **West Center Avenue Sidewalk Connection**

Sidewalk connection from West Center Avenue to South Pirce Street.

Advertise for Bid: Q2

Estimated Cost: \$300,000

### **West 1<sup>st</sup> Avenue Drainage Improvements**

Replacement of an existing inlet that is currently a roadside safety hazard at southwest corner of west 1<sup>st</sup> Avenue and Depew Street. Project will remove existing infrastructure and replace with new inlets and storm sewer pipe and regrade the roadside ditch.

Advertise for Bid: Q2

Estimated Cost: \$300,000

### **West Colfax Avenue Safety Project**

This project phase will construct curbside and street edge treatments. Project elements associated with this phase include curbside improvements focused on repurposing the outside traffic lane for pedestrian use from Sheridan Boulevard to Teller Street. This phase will also include installing continuous sidewalks along both sides of the street. Other improvements will include consolidating and closing driveway accesses, new traffic signals, signalized pedestrian mid-block crossings, new bus lane pullouts, pedestrian lighting, advanced warning signs for pedestrians on the roadway, storm water system improvements, landscaping, wayfinding monumentation, and public art.

### **W-Line Trail Lighting and Raised Crossings**

Installation of new lighting on the W-Line trail from North Lamar Street to Mountair Park. The project will also include raised crossings at N Lamar Street and North Harlan Street.

### **W 3<sup>rd</sup> Ave Drainage Improvements**

Flooding along West 3rd Avenue, east of Depew streets inundates houses on the north side of the street. There is no storm system or formalized ditches in the existing condition. ## Town of Parker – 2026 Capital Improvement Projects

- 1) Annual Townwide Roadway Maintenance Program (Engineering/Public Works) – Work consists of three (3) separate maintenance contracts as follows:
  - i) Resurfacing Program (asphalt mill/overlay)
  - ii) Pavement Preservation Program (slurry/chipseal)
  - iii) Concrete Replacement Program

The first two (2) contracts listed above have been recently competitively bid and are currently in the process of Town Council review/award with contracts expected to be fully executed by the end of the first quarter of 2026. The concrete replacement program will be advertised for bids beginning in mid-January with a contract tentatively anticipated to be executed by the end of the first quarter of 2026. The total for this contracted annual roadway maintenance work is approximately \$7 million and includes the option to renew for up to two (2) additional one (1) year periods. The latest that these contracts will come up again for competitive bidding is 2028.
- 2) E-470/Parker Road/Twenty Mile Road Mobility Improvements (Engineering/Public Works) – This project consists of widening/extending Twenty Mile Road to E-470 plus improvements to southbound Parker Road south of E-470. Design is currently underway with the project anticipated to be bid in the fourth quarter of 2026 with construction occurring in 2027. The budget for the project is approximately \$4 million.
- 3) Hilltop/Parker Road Improvements (Engineering/Public Works) – This project consists of turn lane improvements at the Hilltop Road/Parker Road intersection. The project is anticipated to be bid in the 1<sup>st</sup> quarter of 2026 with construction being completed in 2026.
- 4) 2026 Intersection Improvement Projects (Engineering/Public Works) – This project consists of minor operational improvements at two (4) intersections and is anticipated to be bid in the second quarter of 2026. The budget on this project is approximately \$0.25-million and will be completed in 2026.
